

Local Housing Allowance and housing supply

That this House acknowledges the endemic housing crisis which now affects all communities across the country and the unsustainable rent increases across the private rented sector; affirms the current inadequacy of Local Housing Allowance, frozen since April 2020; believes that Local Housing Allowance has not kept pace with rising rents; recognises that Discretionary Housing Payments are insufficient in reducing the burden on local authority homelessness teams; expresses concern at the strain temporary accommodation is placing on local authority budgets; welcomes any commitment by any of the major parties to increase housing supply over the medium and long term; implores any potential party of government to commit to immediate interventions to alleviate the housing and homelessness emergency in the short term; and urges the Government to unfreeze Local Housing Allowance during forthcoming fiscal events and restore it to, at the very minimum, the 30th percentile of rents in every local authority area.















Well-Fed (Scotland) CIC charity












What are All Party Parliamentary groups?

Tips for Engaging with your MP

- Try to put party politics to one side
- Be prepared to explain yourself
- Put a face and personal story to your email
- Be specific about what you want them to do for you
- Avoid mass email campaigns
- Be persistent and keep in touch

What can you ask your MP or a Member of the House of Lords to do?


- Ask a question to a government minister



To ask the Minister for Women and Equalities, what steps she is taking with Cabinet colleagues to help tackle violence against women and girls.




The Minister for Women sits on the Ministerial Steering Group overseeing the delivery of the Violence against Women and Girls (VAWG) Strategy and the Domestic Abuse Action Plan. This group met most recently on 18 October 2023 to assess progress, which includes;

- Adding the issue of violence against women and girls to the revised Strategic Policing
 Requirement (SPR), meaning it is now set out as a national threat for forces to respond to
 alongside other threats such as terrorism, serious and organised crime, and child sexual
 abuse;
- Investing £168 million through the Safer Streets and Safety of Women at Night funds to make our streets safer;
- Launching a fund for VAWG 'by and for' services over two years to a total of up to £6 million, from 2023/24 2024/25. The fund is for services across England and Wales, supporting LGBT people, people with a disability, or ethnic minorities affected by VAWG;
- Launching the 'Enough' behaviour change campaign in March 2022, which has reached millions of individuals across England and Wales.

Case Study: Period Poverty

- Issue: Free period products for young people on free school meals
- Methods used: Petition, social media, protest, writing to MPs
- Outcome: Government funding
- Campaign Length: 2 years

Children's social care

Inquiry

The Education Committee will assess the current system of children's social care in England.

The Committee will focus on ways to improve early intervention, tackle rising demand and rising local authority spending, and support children with complex needs.

The inquiry will also look into protection for vulnerable children and support for care leavers, and aim to assess the social care market in the context of the private and public sector.

Terms of reference:

- Is the current provision of children's social care sufficient to meet demand?
 - What factors are causing the increase in demand for children's social care?
 - What are the recent trends and causes of out-of-area placements?
- How children's social care can impact a child's educational or long-term outcomes and ways to improve outcomes for care leavers;
- The specific experiences of disabled children or children with additional needs within children's social care, how they differ from their peers, and ways to improve their experiences;



Top Tips for Submitting Evidence

- Be concise
- Refer back to the terms of reference set out in the call for evidence
- Use bullet points and subheadings
- Uses factual information and avoids politicised language
- Do not use jargon
- Consider the audience that will be reading it i.e. intelligent nonexperts
- Include recommendations for action, i.e. solutions to the problem

Do not increase visa fees and the Immigration Health Surcharge

Halt any further increases in visa fees and the Immigration Health Surcharge. Immigrants who contribute through taxes shouldn't face increased financial burdens

More details

We believe these fees are already an extortionate burden on individuals who hold temporary visas, with no access to public funds. It is disheartening that despite our contributions, we are required to pay additional charges just to access essential healthcare services through the NHS. It is crucial to highlight that individuals with work visas diligently fulfil their tax obligations. Yet they are subjected to policies that demand extra payments for access to the NHS. The Government should not increase these even further.



"I have explained to friends and family the whole process from petition through to final feedback. Some were not aware of the petitions process.

"Whilst the debate did not result in law or policy change, this is a significant starting point and, as I explained to our granddaughter, when she gets older society will hopefully be a more autistic friendly and understanding place, because of little actions like this debate.

"Nothing will ever change unless there is a desire and motivation to change it. This is one way of influencing and motivating change.

Case Study: Menopause

Cause: lack of awareness and cost of HRT

Methods: Petitions (less than 10,000 signatures), Westminster Hall Debate with public sharing experiences through a survey, General Debate organised by Back Bench Business Committee, Private Members Bill

Outcome: Longer prescribing cycles so prescription will cost less, Menopause Taskforce
